- 3. The course fees are to be paid immediately after receipt of the invoice by bank transfer without any deductions. The participant bears bank fees.

 4. The course fee does not include any other costs (travel, hotel, etc.) that the course participants incur.
- 5. Cancellation Policy
- 5.1 Cancellations must be made in writing.
- 5.2 Cancellation of a modular course by participants: In the event of cancellation 30 days before the start of the course or earlier, the registration fee and further course payments will be 100% refunded. In the event of cancellation 29 days or less before the start of the course, the registration fee will be withheld or charged. If the participants fail to show up, 50% of the total course fee will be charged.
- 5.3 Cancellation of a keynote, seminar or tutorial by participants. In the event of cancellation 30 days before the start or earlier, the course fees will be 100% refunded. If you cancel 29 days or less before the start, 20% of the total course fee
- will be charged. In the event of no-show, VieSID reserves the right to charge 50% of the total course fee.
 5.4 VieSID reserves the right to cancel courses 2 weeks before the start of the course. Participants will be informed immediately and have the right to a refund of the deposit. Further claims or claims for damages are excluded. VieSID is not
