



3 DAYS KEYNOTE WITH PROF. SADAO SATO

"CRANIOMANDIBULAR ORTHODONTICS"

The goal of this keynote is to provide fundamental knowledge for successful orthodontic treatment of different types of malocclusions without premolar extraction and surgical intervention. Changes in facial vertical dimension and posterior occlusal plane during growth, and the corresponding adaptation of the mandible result in different types of malocclusions. Knowledge about the development of malocclusion during craniofacial growth inform the clinician on orthodontic treatment, thereby overcoming the understanding of orthodontics as means for mere alignment of teeth.
